In honor of Judge John "Jack" Ruffin Jr., Dream Builders and the ACAAA are sponsoring their twelfth annual Judge John H. Ruffin Trailblazer Scholarship Essay Contest. The essay contest is for graduating college-bound seniors only throughout the CSRA. The requirements are a maximum 4 pages, double spaced, 12-point Times New Roman essay. This year the essay writers must address the essay questions listed below, based upon actual research, about the Law Day theme "Voices of Democracy." A minimum award of \$1000.00 each will be given to one male and one female winner, high school senior in the CSRA, and one male and female senior who is a Youth Challenge Graduating Participant. The winners will be awarded at the Law Day Dinner held by the Augusta Bar Association on May 2, 2024.

**ESSAY DUE DATE:** Essays must be emailed to DreamPlanAchieve.jeffords@gmail.com. by noon Monday, April 22, 2024, or mailed to Dream Builders at 437 Walker Street, Augusta, Georgia 30901. If mailed, the essay must be *received* by Monday, April 26, 2024.

**DATE FOR AWARD:** The winners will receive notification by noon Monday, April 29, 2024, and will be awarded at the Law Day Dinner held at The Foundry on May 2, 2024. The winners must be present at the dinner to receive the award. The minimum \$1000.00 award must be used for school or military related purposes. (i.e., tuition, books, tests, college rent).
