	Purchases of tangible personal property or services made by any authority created by local law enacted by the General Assembly or cal constitutional amendment, which authority provides public water or sewer service. <u>A sales and use tax number is not required for this cemption.</u> O.C.G.A. § 48-8-3(1)(B).				
	4. Purchases of tangible personal property or services made by the University System of Georgia and its educational units, the American Red Cross, a Community Service Board located in this state, Georgia Department of Community Affairs Regional Commissions, or specific qualified authorities provided with a sales tax exemption under Georgia law. <u>A sales and use tax number is not required for this exemption</u> . D.C.G.A. §§ 37-2-6.1(d), 48-8-3(8), 50-8-44.				
	The sale, use, consumption, or storage of materials, containers, labels, sacks, or bags used for packaging tangible personal property for nipment or sale. Materials purchased at a retail establishment for consumer use are not exempt. <u>A sales and use tax number is not equired for this exemption.</u> O.C.G.A. § 48-8-3(94).				
	6. The sale of aircraft, watercraft, railroad locomotives and rolling stock, motor vehicles, and major components of each, that will be used orincipally to cross the borders of this state in the service of transporting passengers or cargo by common carriers and by carriers who hold common carrier and contract carrier authority in interstate or foreign commerce under authority granted by the United States Government. Replacement parts installed by carriers in such aircraft, watercraft, railroad locomotives and rolling stock, and motor vehicles that become an integral part of the craft, equipment, or vehicle are also exempt. The exemption does not extend to private carriers. O.C.G.A. § 48-8- 3(33)(A).				
	8. Purchases of tangible personal property or services made by the Federal Reserve Bank, a federally charted credit union, union organized under the laws of this state. <u>A sales and use tax number is not required for this exemption.</u> 12 U.S.C. §§ 53 O.C.G.A § 48-6-97.
